

LEGAL GUARDIAN CONSENT AND INDEMNIFICATION

I understand that The Tour Company shall not be responsible for any passengers' health costs while on tour, and that they shall be fully reimbursed for any and all costs incurred on behalf of any passenger requiring medical care for any reason while on tour. I agree to consult a physician or other healthcare specialist, or agree to inquire from an official information media source healthcare advice regarding any and all required or suggested immunizations and/or vaccinations to the place of travel.

I agree and acknowledge that should I be refused entry at any border crossing, or should the tour itinerary be necessarily altered or otherwise interrupted due to acts of a political or social nature, or due to a natural "Act of God", the tour company shall not be held responsible for any additional costs or expenses which I may incur as a result of such occurrence.

I further agree that any passenger causing property damage to the tour bus, hotel room, or any attraction or restaurant will be solely responsible for reimbursing the Tour Company for any costs that may be incurred due to such actions.

Any person deemed to be in contravention of local laws or statutes may be dismissed at the tour company's sole discretion.
